A RESOLUTION OF THE BOARD OF DIRECTORS OF WILLIAMSON-TRAVIS COUNTIES MUNICIPAL UTILITY DISTRICT NO. 1; PROVIDING FOR CENSURE OF DIRECTOR LINDA FABRE; PROVIDING FINDINGS OF FACT; PROVIDING FOR OPEN MEETING

WHEREAS, Williamson-Travis Counties Municipal Utility District No. 1 ("District") is a political subdivision of the State of Texas, created and operating under Chapters 49 and 54, Texas Water Code; and

WHEREAS, pursuant to Section 49.051, Texas Water Code, the District is governed by a board of directors ("Board"); and

WHEREAS, pursuant to Section 49.057, Texas Water Code, the Board "shall be responsible for the management of all the affairs of the [D]istrict"; and

WHEREAS, the Board finds that, throughout 2024, Director Linda Fabre has repeatedly and consistently abused her title of office by undermining public confidence in duly adopted resolutions, acting unilaterally without the knowledge or consent of a quorum of the Board, interfering in the business of other MUDs to the detriment of the District, harassing and threatening other Directors and Contractors, and surveilling the homes of other Directors:

WHEREAS, on January 17, 2024, the Board met in open meeting and adopted an Order Establishing Deed Enforcement Procedures. Director Fabre voted 'aye'.

On January 31, 2024, the Board met in open meeting and discussed pending deed restriction complaints. During the meeting, Director Fabre described the new policy as "inequitable".

On February 6, 2024, Director Fabre emailed a resident proposing an entirely new system of Deed Enforcement that had not been proposed or discussed with the Board. Her proposed system would place the onus on residents to sue each other for violations of restrictive covenants. (Exhibit A)

Director Fabre showed bad faith by voting in favor of a policy she did not agree with and almost immediately characterizing the policy as "inequitable" while beginning to lobby for her preferred policy. Her action undermined public confidence in duly adopted District policies.

WHEREAS, in open meeting on November 15, 2023, the Board reconsidered the need for Deputy Roosevelt Monroe Stinson of the Williamson County Precinct 2 Constable's Office to be present at Board of Directors meetings. After discussion, the Board took no action, opting to continue using Constable Stinson's services at Board of Directors meetings.

On April 17, 2024, Deputy Stinson texted Director Fabre asking "Is there a meeting tonight? And so [sic] I need to attend?" Director Fabre replied, "There is a meeting but we are plenty safe for you to take the night off." (Exhibit B)

Deputy Stinson inferred that his services were no longer required and did not attend April or May's meetings of the Board of Directors.

Director Fabre had no authority to terminate Deputy Stinson's services unilaterally.

At the May 15, 2024, meeting of the Board of Directors, Director Jones inquired as to why Deputy Stinson was not present:

Director Jones:

Do we know where he is tonight? Monroe?

Director Fabre:

I have no idea.

Director Jones:

Makenzi, do you know where he is tonight?

Director Fabre:

Did you call him, Makenzi? Did you invite him?

Ms. Scales:

No, I am not, I have never been asked to invite Monroe to the regularly scheduled board meeting dates. In the past I was told that

he would, if the meeting date changed, typically get his

information from you, Linda, but no, I have no -1 spoke to him today, yes, but it was strictly because I had not received the timesheets I had requested from Johnson, and Johnson told me he

had provided them to Monroe. He said-

Director Fabre:

He has, in the past, called and asked me if there was a meeting, but

he didn't call me - today.

It is more than reasonable to conclude that Director Fabre knew exactly why Deputy Stinson was not in attendance. She offered no information to the Board and the public about having instructed him not to attend in April and answered questions literally to avoid outright falsehood; careful, lawyerlike answers do not equal transparency and accountability. Reprehensibly, she was not only not forthright about her role in the constable's absence but attempted to falsely place the responsibility at the feet of an innocent District contractor.

WHEREAS, on May 28, 2024, Director Fabre, then President of the Board of Directors, sent an email to the Board of Directors of Fern Bluff Municipal Utility District ("Fern Bluff") under the subject of "May 28, 2024 Citizen Communication Follow Up". In the email she chided the Fern Bluff Board regarding a recently concluded legal matter and informed them that she had filed a complaint with the Office of the Attorney General regarding a recent Public Information Act Request. (Exhibit C)

On May 30, 2024, the District General Manager of Fern Bluff responded to the entire Board of WTC MUD #1, stating in part "It's confusing to me why you wish to involve yourself in our district's affairs. Unlike your district, I can assure you that each of our board members is fully aware and apprised of all district business and have no need for your education."

Even though Director Fabre was holding herself out to Fern Bluff as a private citizen, and sent the email from her private email, her position and reputation is well known by Fern Bluff. It is impossible for her personal actions in this episode to be divorced from her public position as a Director, as evidenced by Fern Bluff emailing the entire WTC MUD #1 Board in response. This interference in the business of other districts tarnishes the reputation of THIS District, further limits the pool of contractors willing to work for us, exposes us to potential adverse litigation, and takes attention away from important District business.

WHEREAS, in January 2024, Director Fabre became aware that Director Hanoi Avila was keeping hens in his backyard. While this is a violation of the restrictive covenants of the

section where he lives, the newly adopted Deed Enforcement Policy was based on complaints; no neighbor of Director Avila had complained.

On March 17, 2024, in a Bills and Invoices Committee meeting, Director Fabre told Director Kelley Masters that she wanted to remove Director Avila from the Deed Restriction Committee (DRC) and place herself or Director David Flores on it in his place. Director Fabre stated that if Director Avila would not step down behind the scenes, she would "have to" discuss his chickens in a public meeting. (Exhibit D) While Director Fabre first attempted to do this in closed session on March 20, 2024, the District's Attorney advised that this was not a topic eligible to be discussed in closed session, and Director Fabre plunged ahead with her exposé in open meeting.

On that night the Board voted to make no changes to the DRC.

Director Fabre continued to inflame public sentiment against Director Avila, as evidenced by public comments by her allies at subsequent meetings – none by his own neighbors.

On August 20, 2024, Director Fabre took advantage of the fact that the Deed Enforcement Rules allow a Director to file a complaint about a violation in any section of the district to file a deed violation complaint against Director Avila. She does not live in his section and no neighbors of Director Avila had complained. The complaint was accompanied by a photo of Director Avila's private backyard that was clearly taken by someone who had reached over his neighbor's back fence. (Exhibit E)

This breathtaking privacy violation is antithetical to the values of this Board and this District. This Board will not tolerate this behavior and condemns it in the strongest possible terms.

WHEREAS On August 21, 2024, immediately following the meeting of the Board of Directors, Director Avila was signing checks at the dais. Director Fabre began to berate him in front of several witnesses, including Makenzi Scales of Inframark and Lisa Rickert of Artesian Financial Services, telling him that he was "a corrupt minister" and "in bed with" District contractors. Director Fabre threatened to show up at Director Avila's church on the upcoming Sunday to "expose you to your parishioners for the fraud you are". (Exhibits F,G, K)

This Board will not tolerate a Director threatening another Director and condemns this behavior in the strongest possible terms.

WHEREAS, on September 25, 2024, Hilary Avila, wife of Director Avila, was at her home seated at a table with an unobstructed view of the street. She observed a vehicle matching the description of the gray Honda CRV belonging to Linda Fabre drive slowly past her home. The passenger (a person unknown to Ms. Avila) took their phone out and pointed it out of the passenger window at the home, appearing to be recording the home as the vehicle drove very slowly past. Security footage at that time captured a gray vehicle outside the home. (Exhibits H and I)

This Board will not tolerate a Director surveilling the homes and families of any Director or Resident of the District for political purposes. Any possible rebuttal that there is nothing illegal about recording someone's home from the street misses the fundamental point that this behavior is far outside commonly accepted social norms. It is not ethical or honorable and has no place in a civil government. We condemn this incident in the strongest possible terms.

WHEREAS, numerous District contractors have been subject to harassment, defamation, unreasonable requests, and have also observed Director Fabre's behavior. (Exhibits J and K)

WHEREAS, Director Fabre's continuous erratic, unstable, and aggressive actions have no place in a civil and functional government and have thrown the Board of this District into turmoil.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF WILLIAMSON-TRAVIS COUNTIES MUNICIPAL UTILITY DISTRICT NO 1, THAT:

SECTION 1. Findings of Fact. The above recitals are true and accurate legislative findings of fact. The recitals are adopted and incorporated herein for all purposes.

SECTION 2. Censure of Director Linda Fabre.

- (a) The Board hereby censures Linda Fabre for the reasons provided above.
- (b) All persons are hereby notified that, unless explicitly indicated in writing and by the signature of the President of the Board, Director Fabre neither speaks for, nor otherwise represents, the Board or the District as a whole.
- (c) The Board hereby notifies the District's Consultants that, henceforth, they are under no duty to interact with Director Fabre, whether in person or in writing.
- (d) By adopting this Resolution, the Board adopts a vote of no confidence in Director Fabre and finds that she has consistently failed to faithfully execute the duties of her office. Therefore, by way of separate resolution and for the reasons provided above, the Board will further consider removing Director Fabre from all District committees and all officer titles within the Board.
- (e) <u>Section 3.</u> Open Meeting. The Board has considered this resolution during a duly noticed meeting that was open to the public, in compliance with Chapter 551, Texas Government Code, and Section 49.063, Texas Water Code.

Re: Deed Enforcement: Unintended Consequences

Shannon, Thank you for your email.

Deed enforcement is proving to be more difficult than imagined for all the reasons outlined in your message, and more. It is becoming more and more apparent to me why many MUD's do not exercise the authority granted by the water code to enforce the deed. It's a palaver.

Perhaps there is another way we could be helpful in these situations without taking ownership of the problem.

What if we were to address each Complainer with a standard form letter that directs them to the recourse offered in their deed. That is, suing your neighbor into compliance. The onus is on them. They can fix any legitimate violation for \$125.00 in small claims court and guarantee it never happens again with an injunction. If they prevail, they likely get their \$125.00 back and the problem is resolved forever.

The MUD's role could be to send 1 courtesy letter to the Offender that informs them of the complaint, includes a copy of the deed that demonstrates the alleged violation is in fact prohibited by the document and informs them that their neighbor has a right to sue them into compliance.

The Complainer would be sent a letter with acknowledgement of the complaint, a copy of the Offenders deed where the explicit violation is highlighted, a copy of the letter the MUD sent to the violator and links to the small claims court solution for their respective county. That gives them the means and the evidence to support their claim.

If the reported violation is not restricted by the deed, then a standard letter is sent to the Complainer along with a copy of the deed, informing them that their complaint is not restricted by the deed along with the path to the small claims solution should they wish to pursue it through the court anyway.

Everyone gets heard, and everyone is afforded the same solution. The MUD would not need to be involved beyond that.

I am interested in any approach that you think might serve this District that would provide for an equitable solution. Perhaps we've gotten too close to the subject to see it clearly? I would appreciate your insight.

Thank you for your current work at the MUD in enacting changes.

I appreciate that Deed Restriction Enforcement has been a tough issue since many voters would like to see some form of it to avoid what AWANA has coined "the Wild West".

Your currently voiced strategy (loosely stated) is to not enforce Deed Restrictions unless a resident complains. This may have come from a desire to keep the peace and have a policy that can be under the control of the sensibilities of the residents of that area. Peacekeeping is a goal I am thrilled to see. However this current plan of action had an unfortunate unintended consequence.

As both of you know my husband ran for MUD Board in 2022 and was the victim of slander from a group called AMWANA. Two days after your MUD ruling on Deed enforcement and a flooding complaint, the neighborhood drunk, a friend of AMWANA members, saw me outside and began to accuse me of flooding my neighbors yard. My neighbor, who I have a great relationship with, also was treated to this man trying to convince him to be mad at us for allegedly flooding his yard. We were both annoyed and stunned. My neighbor politely informed the man that we are at the bottom of the slope and both of our yards are flooded with everyone's yard water, pesticides and pet waste every time it rains heavily. It's called gravity.

The next day a neighbor of an AMWANA member, who I have never seen before, moseyed up to me as I am gardening and started grubbing around for information. This strategy of "gotcha game" has been played out for years in the AMWANA members who became MUD Board Directors. The terror of accusation was used to harass many people who didn't even have a particular restriction obligation.

Unfortunately any malcontent can create an atmosphere of division and McCarthyism when a baser desire of, to be colorful about it, being a peeping Tom or pot stirrer against one's perceived victims or enemies, is encouraged.

While you meant well, vile people will use even the nicest things as weapons against their victims. The terror of accusation has been used and encouraged all through this district, and made it a horrible place to live. That alone lowers a property value to a buyer.

Thankyou for the time and effort you have put into this matter, but would you please reconsider this plan?

Lastly, on a legal note:

Some of the same voters who lobby for Deed Restriction Enforcement reside in Home Owners Associations which the MUD voluntarily does not police. Meaning, these are voters wanting WTCMUD1 Deed Enforcement, yet do not have to oblige themselves to WTCMUD1 Deed Enforcement. Logically, since the MUD chooses not to enforce Deed Restrictions in Home Owners Association sections, there is demonstrable selective enforcement. Even if there was a dire issue that needed legal attention by the MUD, WTCMUD1 will have watered down its enforcement policy creating an avenue for any LLC that has let an rental house become a threat to its neighbors claim the MUD was selective in its enforcement.



Dear Fern Bluff Board of Directors,

I wanted to ensure each of you had the chance to review the certified transcript from the March 28, 2024 hearing regarding your case against Nick Steward and Whendy Martinez for a car cover not prohibited by their deed. The transcript records your representation by Mr. & Mrs. Evans and sheds light on why the Judge ruled in favor of the defendants.

Additionally, I wanted to make sure you had the Order Granting Defendants' Motion for Summary Judgment and the denial of claims brought against them in the event you were not aware of the conditional attorney fees and court costs they have already been awarded when they prevail in any future filings initiated by the Board because the facts in this case have not changed. Cumulatively, the amounts total \$83,500.00.

I've also attached your July 12, 2012 'Amendment to Authority to Appoint Members of the Architectural Control Committee' where Section H of the Amendment "the District desires to amend the Restrictions to give the District the authority to appoint the members of the ACC under the same terms as the Restrictions."

Following the amendment document is the Fern Bluff section 2 deed. Please direct your attention to IV. Term, paragraph 2 - "Any such instrument of amendment or termination must be executed and acknowledged by fifty-one percent (51%) of

the then owners of lots encumbered by this Declaration and filed of record in the Deed Records of Williamson County, Texas." You can read the rest yourself for a full understanding of your obligations to your constituency.

In closing, on March 28, 2024, I requested under the Public Information Act, all of the legal expenses incurred for this case. Your attorney did not respond, and did not request an exception from the Attorney General's Office to allow him to withhold the information. As a result I have filed a complaint on the matter with the Attorney General's Office. Transparency is one of the guardrails that prevents governments from abusing their power.

Affidavit of Kelley Masters

Kelley Masters, being duly sworn deposes and states as follows:

- 1. My name is Kelley Masters. I am of sound mind and capable of making this affidavit.
- 2. I am a Director of Williamson Travis County MUD #1 (WTC).
- 3. Near the beginning of my tenure on the WTC Board in mid-2023, Director Linda Fabre told me that she had photos Director Hanoi Avila's house showing that he was storing children's bikes and toys on the side of the garage, and that she would use the photos if he ever tried to cite a resident for the same infraction.
- 4. At a regular meeting of the Board on October 18, 2023, Lisa Rickert of Artesian Financial Services made a long speech taking the Board (mainly Director Fabre) to task for consuming an unreasonable amount of Artesian's time and focusing on minutiae. This infuriated Director Fabre. She called me on the way home to tell me she was going to submit open records requests to every district Artesian serves and "destroy her" (Ms. Rickert).
- 5. Around the end of January 2024, Director Fabre became aware that Director Avila was keeping backyard chickens.
- 6. On March 17, 2024, during a meeting of the Bills and Invoices Committee, on which I was at that time seated, Director Fabre told me that she wanted to remove me and Director Avila from the Deed Restriction Committee (DRC) and place herself and Director David Flores on the committee.
- 7. While I had, in early January, asked her to take me off the DRC, by March 17 I was aware that Director Fabre had declared our new complaint-based Deed Enforcement policy (for which she voted in favor) "inequitable" and had written to me and a District resident proposing a new policy wherein the MUD's role in deed enforcement would be to "educate" residents about how to sue each other in small claims court for alleged violations of the restrictive covenants.
- 8. Because the new complaint-based policy was only in its infancy, and because I do not believe that encouraging residents to sue each other is good public policy, I told Director Fabre on March 17 that I wanted to stay on the committee. She acquiesced but told me that Director Avila would not remain on the committee because he was keeping chickens in violation of his deed. I reminded her that none of his neighbors had complained, and I encouraged her to talk to him privately. She said she would, but that if he would not step down from the committee, she would "have to" bring up his backyard chickens in open meeting.
- 9. In 2020, Director Fabre passionately defended a resident's right to keep a pot-bellied pig that was the subject of numerous resident complaints (Exhibits A-E). Based on the evidence available and my knowledge of Director Fabre's strong and well-known feelings about deed enforcement by the MUD, I believe Director Fabre was using Director Avila's chickens as an excuse to put herself or an ally on the DRC and begin to

I live less than a mile from the District's boundary and keep chickens; she has visited my home and chicken coop the previous year, and even asked to pet one of my chickens; she never expressed any health and safety concerns about backyard chickens until Director Avila refused to step down from the DRC.

- 1. My name is Hanoi Avila. I am of sound mind and capable of making this affidavit.
- 2. I am a Director on the board of Williamson-Travis Municipal Utility District #1 (WTC MUD #1).
- 3. On August 20, 2024, fellow Director, Linda Fabre, filed a deed restriction complaint against me for keeping chickens in my back yard, even though she does not live near me or even in my section, and none of my immediate neighbors have complained about the chickens. In fact, my neighbors are supportive of the chickens.
- 4. The back yards on my street are bordered by a light industrial office complex.
- 5. The complaint was accompanied by a photo of my back yard that could only have been obtained by someone who had reached over my neighbor's back fence without their permission. (See Exhibit A)
- 6. At the conclusion of the regular meeting of the board on August 21, 2024, 1 still needed to sign checks for the monthly bills, so I did not immediately leave the meeting room.
- 7. While I was signing checks, Ms. Fabre appeared to be extremely agitated. She began verbally berating me, telling me that I was "a corrupt minister" and "in bed with our contractors".
- 8. Ms. Fabre announced her intention to show up at my church on Sunday to "expose" me to my parishioners.
- Several people were still in the room and heard this threat, including our operator, Makenzi Scales of Inframark, and our accountant, Lisa Rickert of Artesian Financial Services.
- 10. Ms. Fabre did not show up at my church the following Sunday.
- 11. On September 26, my wife Hilary told me that the previous morning she had observed Linda Fabre in her car on the street outside my home. Mrs. Fabre's passenger was holding their phone pointed towards our front yard as they slowed and appeared to be recording the front yard of my home.
- 12. Mrs. Fabre has created a hostile environment that makes it almost impossible to do the regular work of the District. I feel threatened and harassed by her actions, both personally and for my family.



Affidavit of Lisa Rickert

Lisa Rickert, being duly sworn deposes and states as follows:

- 1. My name is Lisa Rickert. I am of sound mind and capable of making this affidavit.
- 2. I am the contracted bookkeeper of WTC MUD #1.
- 3. My firm, Artesian Financial Services, LLC, provides bookkeeping services to the district and has since July 1, 2023.
- 4. Our firm presented a preliminary budget to the Finance committee (Linda Fabre and Kelley Masters), in a pdf format for review in August 2023. Linda Fabre took the preliminary budget, removed all GL codes and changed the description and amounts on several line items, even deleting some line items. We learned after the fact that she presented this budget at a special meeting on September 6, 2023 prior to the regular meeting on September 13th the date we were scheduled to review and adopt the budget. I confirmed with attorney Cole Konopka that she requested the special meeting and instructed his office that we not be included in a notification to attend. I discussed this at the next meeting that we would have to change and clarify the budget for us to be able to incorporate the data into our financial systems for reporting. I spoke of this to the board at their meeting on October 18th, 2023, that Director Fabre was over-stepping her position as a board member.
- 5. From the time we started providing services for William Travis Counties MUD 1, the Financial Committee (Linda Fabre and Kelley Masters), required a specific time to meet prior to the regular meeting to review invoices. The vast majority of the time, Linda Fabre was the only person from the committee that responded to emails and participated in the many Team meetings. At every meeting, Linda is not simply reviewing invoices, but is giving direction to our firm and the General manager to remove items from the invoices or to pull checks just prior to a meeting. I discussed this with legal (Cole Konopka) in the fall of 2023 and expressed my concerns that this is preventing the rest of the board from seeing the information and making a decision. At the May 15th meeting, I again expressed my concerns that emails and instructions came directly from Linda, not the committee. I have attached several emails from August of 2023 through January of 2024 for examples (Exhibit A).
- 6. In a discussion with the attorney, I expressed concern about Linda's comments from the October 2023 meeting that the minutes only be distributed to the BOD. I conveyed my concerns about our firm being included in the minutes recording decisions and discussions at the meetings. I felt that we should have the opportunity to review in

- advance so that we could provide input. It is also a valuable tool for preparing for the next meeting. I do not have that restriction with any other clients.
- 7. Over the last three meetings (July 17, Aug 21 and Sept 18 of 2024), Linda Fabre has made a motion to fire or censure our firm due to allegations of wrong-doing. The motion fails every time due to a majority voting against the motion. We consider this a form of harassment since she continues to do this knowing that a majority will not approve.
- 8. During meetings, Linda constantly makes comments and interrupts during our report about errors and mistakes that we have made. At the June 19th meeting, she accuses us of paying the constables at the wrong hourly rate. We are not given a chance to reply or have a chance to review the agreements to confirm or deny before she peppers us with another allegation of doing something wrong. We were able to confirm that we have been paying the correct rate since we started providing services for WTC1.
- 9. I received an email form Cube Smart, a vendor that the district uses for storage on May 31, 2024. We are registered as the bookkeeper and the contact for this vendor to reach out to for billing questions. Inframark is the company that they interface with to store various equipment and other items at their facility. They were emailing me to let me know that Linda Fabre was requesting information about gate access for drivers after hours, to know how often they used after hours access. The district pays \$15 per month for after hour access. She also indicated to Cube Smart that she had taken a position with my company, Artesian Financial Services, LLC and wanted to know if they should add her to the contact list. I have attached the email (Exhibit B).
- 10. Linda Fabre has created a toxic environment for our firm in her actions and words at public meetings and via email and Teams meeting between board meetings. On June 19th, Linda questioned my appearance at the meeting and asked why I attended. I told her that I was the bookkeeper and that it was an open meeting to the public. She then questioned as to what I would charge the district, who invited me, and tuned to Director Avila and shouted to him that he had overstepped his bounds by approving me to come. I tried to explain that I had simply informed President Avila that I would attend. I did not charge the district any additional fees for travel for that meeting.
- 11. Linda Fabre has caused our firm to charge additional hours due to the additional time spent answering questions and holding meetings in between the Board meetings. These are not included in our Agreement as discussed in a board meeting. Linda made a motion at the November 15, 2023 meeting to decline paying our invoice, only to lose that motion due to a lack of majority. We consider this another form of harassment. Our firm has discussed with legal counsel, Cole Konopka and President Avila that we are considering tendering a resignation as the district's bookkeeper. The harassment and rude behavior of Director Fabre makes the environment untenable for my employees.

Issuing 220 checks enmasse is a huge task. No question about that. That coupled with the continual onboarding of our records, and preparing for the next audit is overwhelming. It would be a lot of work under the best of circumstances and of course we will work with you. There is no rush to act on this. I'm only gathering information at this point.

I would like to find a way (in the future) that these deposit refund checks could be issued without a notable impact to the workload and covered in the monthly base fee. That information would be helpful for the Board to decide where to draw the line for issuing checks in lieu of a credit on the account. You'll notice in my spreadsheet that I selected \$300 as the refund by check amount; however, it may be more cost effective to draw the line for refund checks at \$400 which would reduce 220 checks to only 62 which seems more manageable.

I completely agree that getting the District's books in order is the top priority and I look forward to the day that is done. Whew....

I cannot speak for the Operator, but this will be a huge task to accomplish and an additional cost to the district. Approximately 350 transactions totaling nearly \$110,000. We estimate that this will be an additional 20-25 hours to start, at an hourly rate of \$150. The entering and verifying of the additional checks along with the follow up that they cleared and the re-issuances that will come later may cause that number to increase.

The timing of this could not be worse, especially since we are still onboarding your financials and working on audit preparation. We recommend that you consider deferring this action until next year and allow us to bring the districts books into order and streamline your processes and procedures to maximize efficiencies.

The bank account is Central Bank and we will move the money needed to execute the transactions when the time comes.
