RESOLUTION OF THE BOARD OF DIRECTORS OF THE WILLIAMSON-TRAVIS COUNTIES MUNICIPAL UTILITY DISTRICT NO. 1; ESTABLISHING COMMITTEE POLICIES; ESTABLISHING COMMITTEES; APPOINTING MEMBERS TO SUCH COMMITTEES; PROVIDING FINDINGS OF FACT; PROVIDING FOR OPEN MEETING

WHEREAS, the Board of Directors (the "Board") of the Williamson-Travis Counties Municipal Utility District No. 1 (the "District") has previously established various committees to assist in carrying out the District's duties (the "Committee(s)"); and

WHEREAS, the Board now wishes to create additional Committee(s), confirm certain existing Committee(s), and appoint new members to the Committee(s); and

WHEREAS, the Board also wishes to establish policies memorializing the membership, qualifications, duties, responsibilities, and other matters pertaining to the Committee(s); and

WHEREAS, the Board finds it to be in the best interest of the public to establish said policies and to create additional Committee(s), confirm certain existing Committee(s), and appoint new members to the Committee(s).

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF WILLIAMSON-TRAVIS COUNTIES MUNICIPAL UTILITY DISTRICT NO. 1, THAT:

SECTION 1. The Board hereby finds that the above recitals are true and accurate legislative findings of fact.

SECTION 2. The Board hereby confirms the following policies for District Committees:

- **1.1. Membership:** Each District Committee shall be comprised of up to two (2) Board member, as appointed by a majority vote of the Board ("**Member(s)**").
- **1.2 Purpose and Duties:** The purpose of each Committee is to advise the Board on matters relating to the stated purpose of the Committee as described in <u>Exhibit "A"</u>.
- **1.3 Meetings:** Committees shall meet at least annually and may meet more often, as may be authorized by the Board.
- **1.4 Terms:** The terms of office for each Member shall be two (2) years, terminating at the end of each election cycle. Members may be reappointed to subsequent terms.
- **1.5 Vacancies:** Any vacancy on a Committee shall be filled for the unexpired term by the Board in accordance with Section 1.1 of this Resolution.
- **1.6** Removal: All Members serve at the will of the Board, and any Member may be removed by an affirmative vote of three (3) members of the Board.
- 1.7 Advisory Nature of the District Committees: Committees are advisory in nature and shall be responsible to and report to the Board. District Committees and their Members have no authority to set policy, expend funds, contract, or assume

obligations on behalf of the Board and/or the District.

1.8 Board Reports: Committees shall report on their activities to the Board at least annually, and more often if needed or requested by the Board (the "**Report**"). The Report can be either oral or written and shall include a description of the Committee's activities for the preceding period and any on-going or outstanding activities or tasks.

<u>SECTION 3.</u> The Board hereby creates new Committee(s) and affirms existing Committees, including appointment of Committee members, all as shown on <u>Exhibit "A"</u>.

<u>SECTION 4.</u> The Committees, their respective members, and the ending dates of the members' current terms are shown on <u>Exhibit "A"</u>. Upon the expiration of each of their current terms, new Members shall be appointed or reappointed consistent with Section 1.1 of this Resolution.

SECTION 5. This Resolution supersedes and replaces all previous resolutions and policies relating to the subject matter hereof.

SECTION 6. The Board has considered this resolution during a duly noticed meeting that was open to the public, incompliance with Texas Government Code Chapter 551, the Texas Open Meetings Act.
