AN ORDER OF THE BOARD OF DIRECTORS OF WILLIAMSON-TRAVIS COUNTIES MUNICIPAL UTILITY DISTRICT NO. 1; REQUIRING USERS OF DISTRICT SOLID WASTE REMOVAL SERVICES TO STORE TRASH CARTS OUT OF PUBLIC THOROUGHFARES, SIDEWALKS, ROADWAYS, PARKS, OTHER COMMON AREAS; PROVIDING PENALTIES; PROVIDING FINDINGS OF FACT; PROVIDING FOR OPEN MEETING

WHEREAS, Section 49.211, Texas Water Code, grants Williamson-Travis Counties Municipal Utility District No. 1 ("District") "the functions, powers, authority, rights, and duties that will permit accomplishment of the purposes for which it was created or the purposes authorized by the constitution, [the Texas Water Code], or any other law"; and

WHEREAS, Section 54.203, Texas Water Code, provides, "A district authorized to purchase, construct, acquire, own, operate, maintain, repair, improve, extend, or establish a municipal solid waste collection and disposal system, including recycling, inside and outside the district and make proper charges for it. A district may require use of such services as a condition for receiving other district services. A district may enter into an exclusive contract with a private entity to provide such services to all land and persons within its boundaries[]"; and

WHEREAS, pursuant to the authority granted under subsection 49.213(c)(6), Texas Water Code, the Board of Directors ("Board") of the District previously entered into a contract with Waste Management of Texas, Inc. ("Waste Management"), to provide municipal solid waste and disposal services ("Services") to residences within the District's boundaries; and

WHEREAS, Waste Management provides the Services, in part, by utilizing large recycling and trash disposal containers ("Carts"), which residents must leave at their curbs in order for Waste Management to provide Services; and

WHEREAS, District contractors and Directors have observed that some residents within the District routinely leave their Carts at the street curb or in plain sight of the public for extended periods of time, well after Services have been provided; and

WHEREAS, the proliferation of Carts left in plain view creates (i) a health and safety hazard by interfering with the flow of traffic on roadways within the District, as well as (ii) aesthetic blight within the District; and

WHEREAS, pursuant to Section 49.004, Texas Water Code, the Board is authorized to "set reasonable civil penalties for the breach of any rule of the [D]istrict that shall not exceed the jurisdiction of a justice court as provided by Section 27.031, Government Code;" and

WHEREAS, in order to protect the health and safety of the District and its residents, the Board hereby adopts reasonable rules requiring all users of the Services to store their Carts outside of public thoroughfares, including, but not limited to sidewalks, roadways, parks and other public common areas;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF WILLIAMSON-TRAVIS COUNTIES MUNICIPAL UTILITY DISTRICT NO. 1, THAT:

SECTION 1. Findings of Fact. The above recitals are true and accurate legislative findings of fact. The recitals are adopted and incorporated herein for all purposes.

SECTION 2. Open Storage of Carts Prohibited.

- (a) All users of Services within the District shall store their Carts outside of public thoroughfares, which include, but are not limited, to sidewalks, roadways, parks and other public common areas.
- (b) Carts may be placed at the curb of residences no more than 24 hours prior to, and left as such no more than 24 hours after, 12:00 PM of the day Services are schedule for that particular residence.
- **SECTION 3.** Penalty for Violation. Pursuant to Section 49.004, Texas Water Code, as amended, the District may assess civil penalties not to exceed those provided under Section 27.031, Texas Government Code, as amended, against any person or entity found to be in violation of this Order.
- **SECTION 4.** Repeal of Conflicting Provisions. This Order supersedes and replaces all previous orders, resolutions, or other policies relating to the subject matter hereof.
- **SECTION 5.** Open Meeting. The Board has considered this Order during a duly noticed meeting that was open to the public, incompliance with Chapter 551, Texas Government Code, and Section 49.063, Texas Water Code.
