Report Summary

WTC MUD No. 1: 5-Year Park Plan

The Williamson-Travis Counties MUD #1 (the District) is preparing a 5-Year Park Plan to identify strategies for maximizing the value of its park system for the benefit of all residents. The District hired a planning consultant, Verdunity, to assist in the preparation of this plan and provide objective and professional guidance throughout the process.

To ensure the adopted park plan reflects the specific needs of the community, the planning process is designed to involve meaningful public participation from beginning to end.

The process is being guided by a resident Advisory Committee, which includes representation from each of the District neighborhoods. In addition to consistent and ongoing input from this Committee, Phase 1 of the planning process sought to formally engage the public in the following ways:

- In-person conversations among residents, the consultant, and Advisory Committee members during Verdunity's day-long District site visit.
- Focus Group discussions on the day of Verdunity's site visit.
- Community-wide survey (Survey #1), which is the first of two surveys that will be conducted as part of the planning process.

The results of each of these input opportunities has been documented in this Public Input Report. Additional input opportunities will be provided in phases 2 and 3 of the planning process.

Key Findings

Based on the results of all public input gathered in Phase 1, the Advisory Committee, in collaboration with Verdunity, identified the following key findings:

- The vast majority of process participants value and appreciate our District's park system.
- Participants place high value on well-maintained, clean, and safe facilities and have noticed that maintenance efforts have fallen short in recent months.
- Participants view parks as important places for socializing and spending time with neighbors.
- Participants prefer to visit parks that are close to their homes and within a convenient walking distance, which emphasizes the value of the District's smaller park and pond areas.

- Participants feel they do not have adequate information about the District's park system or the spaces and amenities available to them, and do not have clear knowledge of who to contact with a question or concern about the parks.
- Participants value park spaces that offer a diversity of amenities for different types of users.
- Participants value park spaces that provide access to natural areas and that leverage natural features to create a welcoming and comfortable space.
- The most frequently cited *current* park uses are walking/jogging/trail use and playing with children/playing on playscapes.
- Participants value improvements that can mitigate the Texas summer heat and allow people to enjoy the parks throughout the year.
- Based on a selection of 23 options for possible *future* improvements (see Appendix A for survey questions), the top ten preferred improvements (based on an average/mean rating) are, in order of preference:
 - 1. Enhanced trails and paths
 - 2. Improved lighting
 - 3. Landscaping and beautification
 - 4. Quiet areas
 - 5. Community events
 - 6. Water play areas
 - 7. Volunteer opportunities (tied with water play areas)
 - 8. Natural playscapes
 - 9. Enhanced natural areas
 - 10. Social gathering spots.

These preferences emphasize a desire for community-oriented spaces that preserve and celebrate the natural environment, are comfortable and safe, and that provide opportunities for residents of all ages and interests to access and enjoy the space.

Key Directions

Based on the input received during Phase 1, the Advisory Committee, in collaboration with Verdunity, identified the following "Key Directions," which will provide guidance to the consultant and Advisory Committee on which ideas to explore further in Phase 2 of the planning process. Key directions do not represent final plan recommendations and are subject to adaptation and change as the planning process progresses.

The following are listed in no particular order of priority or importance.

Key Park System Goals:

- Strive for meticulous maintenance and beautification of our parks and ponds to maximize value to the entire community.
- Improve the marketing of and communication about our park system to increase awareness of the parks, ponds, and District amenities; maximize and diversify use of these facilities; and encourage resident involvement and volunteerism.
- Expand opportunities for residents to access and enjoy the natural environment by actively managing and caring for our existing natural spaces, pursing environmental restoration opportunities, and enhancing amenities and infrastructure designed to provide access to these spaces.
- Aim to provide a diversity of year-round amenities for all age groups, interests, and ages, including seniors, teens, and adults without children.
- Think "hyper-local" by investing in our pocket parks and smaller ponds, recognizing the value of these spaces to nearby residents for play, social gathering, and time outside.
- Leverage a broader range of funding and implementation strategies to make improvements to our park system, including grants, private donations, and volunteerism.

Key Park System Projects (see Results: Consultant Site Visit starting on pg. 9 for park locations and descriptions)

- Preserve and improve our trails and pathways, focusing on user experience, signage, shade, maintenance, safety, and interconnectedness, and recognizing how these trails help connect people with key community destinations such as schools. Pursue opportunities for inter-governmental cooperation (e.g., LISD) to help achieve these goals.
- Pursue natural area restoration in parks and ponds throughout the District, including replacement of turf grass with native vegetation and a tree planting program.
- Institute a multi-tiered "Play in the MUD" campaign aimed at celebrating our park system; increasing awareness of our parks, ponds, and amenities; and increasing and

- diversifying park use. This may include promotional work, hosting of community events, and establishing volunteer groups and programs.
- Enhance the functionality and user-experience of existing amenities through incremental, smaller-scale projects.
- Investigate "water-play" options/alternatives as a longer-term investment.

Key Park and Pond Projects

Anderson Mill Pond

- Enhance the trail loop by installing shade and improving safety, including the segment that connects this pond with Cashell Wood Pond, taking into consideration this trail's contribution to providing a safe route to Cypress Elementary, Cedar Park Middle School, and Cedar Park High School.
- Perform incremental enhancements to the north end of the park (picnic area and swings) to enhance comfort and user experience, including the maintenance of tree cover in this area
- Build on existing signage that emphasizes the pond's natural environment.
- Improve marketing of the existing disc golf course.

Anderson Mill West Park

- Pursue projects that improve safety and user experience, focusing on the following key areas:
 - Lighting (dark-skies compliant),
 - o Adjacent street safety,
 - o Relationship with and proximity to the elementary school,
 - o Functionality of the basketball and volleyball courts,
 - o Tree maintenance and preservation,
 - o Provision of shade,
 - o Accessibility for all ages and abilities.
- Diversify amenity options for teens.
- Enhance park space for social gathering, recognizing the park's frequent use for both community and private events, its centrality and predominant location in the District, and its size and availability of space.
- Investigate options for a water play feature as a potential longer-term investment.

Aster Pass Park

• Install additional play equipment.

- Identify improvements to enhance use as a smaller-scale neighborhood gathering space, working with neighbors on the development of plans and implementation.
- Enhance signage and the park entryway to improve the visibility and accessibility of this park space and beautify the entryway corridor for surrounding residents.

Aster Pass Pond

- Pursue environmental restoration, replacing high maintenance turf grass with appropriate natural vegetation and trees.
- Install educational signage about natural ecosystems, green infrastructure, and the function of stormwater detention areas.
- More closely observe use of this space to identify ways to improve comfort, safety, and user experience, taking into considering the pond's relationship to Cypress Elementary School.

Cashell Wood Pond

- Improve the safety and comfort of the trail connection between Cashell Wood Pond and Anderson Mill Pond, considering options for lighting, seating, and beautification, also taking into consideration this segment's contribution to providing a safe route to Cedar Park Middle School and Cedar Park High School.
- Install seating and shade to the existing observation deck to encourage lingering in this space and to complement the adjacent Little Library and mailbox cluster.
- Pursue environmental restoration, replacing high maintenance turf grass with appropriate natural vegetation and trees.

Hatch Pond

- Improve access into pond basin through installation of steps and possibly an embankment slide.
- Improve trail experience through reinforcement of edges, reshaping and widening of the trail, where needed, and installing distance markers and signage.
- Provide storage for portable recreational and game equipment, such as pop-up soccer goals to expand opportunities for use of the basin.

Lakeline Oaks Park

• Install green infrastructure and water conservation demonstration projects around the District buildings, such as rain gardens and rain barrels, and utilize these as opportunities to beautify the facility, reduce water consumption, and educate residents about water conservation.

- Develop a multi-year plan for planting additional trees in this park, both along the street frontage, and in key areas of the park to enhance shade, beautify the park, and create defined spaces within the open and undeveloped portions of the park.
- Enhance the central open space area of the park in ways that promote social gathering and provide alternative uses for teens, seniors, and adults without children.

Little Elm Pond

- Pursue an access easement or other arrangement with LISD to interconnect Little Elm Pond with Madeline Loop Pond.
- Pursue environmental restoration, replacing high maintenance turf grass with appropriate natural vegetation and trees.
- Work with the Lakeline Oaks HOA and Naumann Elementary on opportunities for additional use of this space.

London Lane Pond

- Install a water source within the park to provide easily accessible and continuous water for dogs and a double gate entry to help make entry and exit from the park safer and more comfortable.
- Improve marketing of this space, as many residents are not aware the District has a public off-leash area.
- Plant additional shade trees to make the space cooler and more comfortable for both people and their dogs.

Madeline Loop Pond

- Install a trail connection from the western side of the pond out to Sun Chase Boulevard.
- Work with LISD to formalize the connection between the pond trail and Cedar Park Middle School.
- Pursue environmental restoration, replacing high maintenance turf grass with appropriate natural vegetation and trees.

Old Mill (Gazebo) Park

- Identify improvements to enhance this park's use as a smaller-scale neighborhood gathering space, working with neighbors on development of plans and implementation.
- Explore opportunities for community gardens.
- Install a low and decorative fence or other barrier to better protect the park from the street and improve safety.

Sun Chase Park

- Install a new play structure on the site of the previous structure. The new structure should be designed to complement and celebrate the trees and natural character of the park.
- Install informational trail signage and mile markers along the trail.
- Install tree swings in appropriate locations throughout the park.
- Refresh and upgrade the picnic area at the rear of the park, including the addition of a grill area.
- Develop a long-term care plan for the natural eco-system of this park, engaging both a certified arborist and potentially an urban forester.

Vestavia Ridge Pond

• Identify opportunities to improve the safety and reasonable accessibility of this space, recognizing that neighborhood children often play in the basin.

Volente Hills Park

- Enhance signage and the park entryway to improve the visibility and accessibility of this park space.
- Work with neighbors to develop plans to enhance this space for gathering and play.

In May 2021, the District's park planning consultant, Verdunity, visited the District and spent a

full day touring the 14 parks and ponds. Each location was visited according to a schedule, which was published on the District's website and through social media, including Nextdoor and several Facebook group pages, to encourage residents to participate in the site visits and meet and speak with the consultant.

The Advisory Committee tried to build the schedule around times of day when certain parks were likely to have higher levels of activity to maximize opportunities for the consultant to observe how people use the space and to engage park users in conversation. For example, the visit to Anderson Mill West Park was scheduled for immediately after elementary school students are released for the day because children and their parents often spend time in the park after school.

While these site visits only a provided a snapshot of how the District's parks and ponds are typically used, Verdunity's unfamiliarity with the District allowed them to observe conditions and speak to residents with objectivity on a day in which the weather was nice and level of activity was expected to be typical.

Below are Verdunity's observations from that day, broken down by park or pond.

Anderson Mill Pond

Anderson Mill Pond is a large stormwater detention area located along Anderson Mill Road and adjacent to the Volente Hills neighborhood. In recent years the District has improved and beautified the pond area by installing a walking trail, benches, landscaping, dog waste stations, trash cans, swings, picnic tables, signage, and a five-hole micro disc golf course.

- The disc golf course signage is user-friendly and attractive and could be used as an example for other District parks.
- The wildflowers that grow in pond are appreciated by residents, and these should be maintained or added to.
- The walking trail needs to be properly maintained and weeds need to be prevented from growing within the pathway.
- Due to its location along a busy arterial roadway, attention must be paid to the safety and comfort of this space.

Anderson Mill West Park

Anderson Mill Park is a larger community park located in the center of the District in the Anderson Mill West neighborhood, across the street from Cypress Elementary School on one of the District's main collector roads, El Salido Parkway. The park has a large, central playground area for children of different ages; two open space (unimproved) areas; a garden; restrooms; tennis, basketball, and volleyball courts; a walking trail; restrooms; picnic tables and grills; and a large, covered pavilion.

- The combination of location and amenities at this park gives it the feel of a "public square," a place where the neighborhood comes together.
- The sand volleyball court has not been well maintained and therefore is not frequently used for playing volleyball.
- The basketball court could use some modifications to make it more usable, possibly including an adjustable height net.
- The swings get very hot during the warmer months of the year.
- The Garden of the Wild Things brings a unique character to the park and is a space that residents have contributed to building and maintaining.
- Walking trails lack proper lighting for evening or early morning walking and running.
- Trails need to be maintained in a way that allows children to walk and bike safely to
- Fencing or other barriers could be installed to protect children and walkers and bikers from the street.
- The presence of this park is a selling point for houses in the area and additional improvements would increase its influence on surrounding property values.
- There is a need to better maintain some of the landscaped and open space areas, the trees, and some of the playground equipment to build on the park's existing strengths and make it a better gathering area for residents.
- Many local groups already meet at this park, at least partially due to its proximity to the school.
- This park would be an ideal location for a splash park or water play amenity.
- There are opportunities to construct amenities that encourage residents to gather and interact, such as a fire pit ring, outdoor kitchen space, or stage area. Open areas could be adapted to serve this purpose.
- The existing gazebo could be adapted to become a playhouse for kids since that's what it is predominately used for.









Aster Pass Park

This small pocket park is the former site of a water tower and is tucked away behind the yards of several homes in the Anderson Mill West neighborhood. The park is accessible only by a narrow access drive that runs between two residential properties and is otherwise framed on all sides by the backyards of adjacent homes. Existing amenities include toddler play equipment and a circular walking path.

- The park's intimate atmosphere and gated entryway makes it a good space for small children to play and neighbors to gather.
- The park's secluded location and narrow access point make it hard to find for anyone who doesn't know it's there. To the average person passing by, the park appears to be private property, which may prevent the park from being used as much as it could be.
- Several trees were killed during the February 2021 freeze and need to be replaced.
- A small water feature would be ideal for young kids and would celebrate the site's former use as a water tower location.
- The park would make a safe space for hosting small-scale neighborhood gatherings.









Aster Pass Pond

Aster Pass Pond is a small stormwater detention basin adjacent to Cypress Elementary School in the Anderson Mill West neighborhood. In recent years the District has improved and beautified the pond area by adding a walking trail, benches, an observation deck, landscaping, and trees, including two Weeping Willow trees, which are otherwise a unique sight in the District.

- Due to the pond's location next to the school, this space receives a lot of after-school activity as children and parents pass through on their way home. Kids enjoy playing in the basin and underneath the observation deck, where concrete stormwater conveyance blocks create a make-shift seating area.
- The pathway needs to be better maintained to keep it safe and useable, particularly because it is heavily used as a route to and from school. Areas that have eroded away need to be reinforced and refilled.
- The quality and variety of landscaping in this park is a good model for others (variety of trees and other perennial grasses and shrubs)

- Future improvements could focus on signage to educate residents on the value of the space for stormwater management and allow them to better engage with the landscape.
- A crosswalk in the street adjacent to the park would improve the park's function as a safe route to and from school. Actively promote this park for that purpose.







Cashell Wood Pond

Cashell Wood Pond is a stormwater detention basin located in the Volente Hills neighborhood. In recent years the District has improved and beautified the pond area by adding a paved sidewalk that connects this pond with Anderson Mill Pond, an observation deck, benches, picnic table, landscaping, and one of the District's several Free Little Libraries. The pond is also located next to one of the neighborhood's mailbox clusters, which creates daily opportunities for people to pass by the park.

Site Visit Take-Aways:

• Adding seating and shade to the observation deck and shade over the picnic area would make this a better place for people to linger.

- The path connecting Cashell Wood Pond to Anderson Mill Pond is well-used, particularly since it is cool and shaded. However, there are some safety concerns, especially for seniors. The steps along the path are hard to see in the low light and need to be better marked; there needs to be a handrail located at the Cashell Wood Pond/Anderson Mill Pond intersection, due to the steep incline at this location; and there needs to be some lighting along the path because the tree canopy makes this corridor very dark in the early morning and later evening.
- Dog waste stations are important and signage about picking up after your dogs would be useful, as people tend to walk their dogs in this area and fail to pick up after them.







Hatch Pond

Hatch Pond is very large, square stormwater detention basin located off Hatch Road in the oldest and eastern-most portion of the District, in the Anderson Mill West neighborhood. Hatch Pond is accessible from both Hatch Road and Yequa Creek Road on the opposite side. The basin is encircled with a walking path and has a small, shaded children's play area in the southern corner of the Pond, off of Yequa Creek Road. The basin has chain-link baseball backstops in all four corners, and because the basin is essentially a large, open field, it is used by residents for a variety of games, sports, and activities.

Site Visit Take-Aways:

- The baseball field areas are not used as frequently as they once were.
- The trail is used heavily for walking.
- The basin is not easily accessible because there are no steps or formal access points. You can only get into the basin by walking down the grass embankments, which are fairly steep in some areas.
- There are opportunities to plan activities, games, and sports for this space, and possibly coordinate with Hill Country Bible Church across the street to organize activities.
- Soccer goals would make a good addition to the field.
- Preserve and enhance natural vegetation in this Pond, including the trees.







Lakeline Oaks Park

Lakeline Oaks Park is a large neighborhood park, located on Old Mill Road in the Lakeline Oaks neighborhood. The park has two playground areas, basketball and tennis/pickleball courts, restrooms, grills and picnic tables, a covered pavilion, and is also home to the District's community building, office, and Board of Directors' meeting room, which makes it a symbolically important public space representation of the District.

Site Visit Take-Aways:

- The combination of amenities at this park make it an ideal gathering place for residents and a good location for future community activities.
- The tennis courts and relatively new pickleball courts are a heavily used District amenity, although there is some tension between tennis players and pickeball players due to this now being a shared space.
- The basketball courts are heavily used by all age groups.
- This park is a good location for a community billboard with news and announcements.
- Better use could be made of the open grassy area in the center of the park; a community game box with like a bocce ball set, cornhole equipment, and similar would provide one way to make use of this area.









Little Elm Pond

Little Elm Pond is a stormwater detention area located on the periphery of the District in the Lakeline Oaks neighborhood, sandwiched between Naumann Elementary school and a busy commercial area on Lakeline Boulevard (outside the District boundaries). Of all the ponds in the District, Little Elm has received the least number of improvements, but does have some

landscaping, benches, and a dog waste station. A gravel access drive provides an opportunity to walk up and back along the tree-lined perimeter of the pond.

Site Visit Take-Aways:

- The gravel driveway needs some maintenance to remove potholes and grass and replace gravel in areas where it has washed away.
- This access point is not a particularly comfortable place for people to walk because it lacks shade and also does not connect to anything; it is an up and back walk only.
- There are opportunities for collaboration with the elementary school to improve the use and function of this space, potentially for outdoor education.
- A trail connection to Madeline Loop Pond would make the Little Elm corridor a much more functional space.





London Lane Pond

London Lane Pond is a deep stormwater detention basin located close to Anderson Mill Road in the Anderson Mill West neighborhood. The space doubles as an off-leash area for dogs and has been improved with a dog waste station, picnic table, separate gated area for smaller dogs, and benches. To provide water for thirsty dogs, a water cooler station and dog bowl was also installed.

- The water cooler station needs to be repaired.
- The main portion of the pond gets very hot in the warmer months due to lack of shade.
- The metal guard rail along the top of the pond does not fit in with the residential character of the neighborhood.
- The land behind the pond is being cleared for commercial development, which may change the character of this space.

• Consider adding simple agility structures or a storage box for dog toys (balls, frisbees, etc.).







Madeline Loop Pond

Madeline Loop Pond is a very large stormwater detention area located behind homes in the Hunter's Glenn neighborhood and backing up to Cedar Park Middle School. The pond area has a secluded feel and is only accessible through a narrow gravel walkway located between two residential properties. A gravel trail wraps around two and half sides of the pond and a long wooden bridge spans the concrete stormwater infrastructure to provide trail continuity. Exercise equipment and a picnic area are located at the eastern end of the pond. Several Purple Martin bird houses are installed in the basin.

- The exercise equipment is a good amenity but does not appear well maintained.
- The trail would be more functional if it connected to something or looped around. A connection to Sun Chase Boulevard would help and could connect this space to the

walking trail at Sun Chase Park. A connection to Little Elm Pond is also possible in the wooded area at the northeast corner of the park.

- The only vegetation in the pond is turf grass but, natural vegetation would improve the natural feel of this pond.
- Mile markers would be useful for trail walkers.
- Kids from the middle school have created their own makeshift trail connection through the tree-line that divides the school property from the pond.









Old Mill (Gazebo) Park

Old Mill Park (also known to residents as "Gazebo Park") is a small, linear pocket park located along Old Mill Road in the Hunter's Glenn neighborhood. The park is predominately an open lawn with modest-sized trees and has a little gazebo in the center. The park is also home to one of the District's Free Little Libraries. The park is bordered on three sides by the fenced backyards of adjacent residential properties.

Site Visit Take-Aways:

- Incremental and small-scale changes to this space could do a lot to increase its value to surrounding neighbors.
- Gardens supplemented with composting areas would beautify this park and make it a more desirable place to spend time.
- Stone animal statues or simple climbing structures could add interest to this space.
- Proximity to the street and lack of a physical barrier between the park and the street represents a safety concern for park users with small children.



Sun Chase Park

Sun Chase Park is wooded natural area located just off Old Mill Road on Sun Chase Boulevard in the Hunter's Glenn neighborhood. The park has narrow street frontage but extends deep into the space between two residential blocks, creating a secluded and peaceful park space, surrounded on three sides by the backyards of residential properties. A network of gravel trails meanders through the trees and connects walkers and joggers from the street all the way to the back corner of the park. A recently installed bridge links the trails into a continuous loop over a stormwater drainage channel. Landscaping and benches have been installed along the trail to complement the natural ecosystem. The back area of the park has picnic tables and a horseshoe pit.

- The abundance of shade makes this park an ideal place to spend time in the warmer months.
- The lift station located along the park's street frontage further obscures this park from the casual observer.
- There was formerly a children's playscape located toward the front end of the park. It was well-loved by residents but had to be removed because it was damaged and became a safety concern. Residents have requested the structure be replaced.
- It is important to preserve the natural character of this park because it is part of what makes the space so unique.
- Connecting this trail loop with Madeline Loop Pond across the street would create a wonderful and long trail corridor.

- Trail markers and trail signage with information on the length of the trail would be helpful for residents who like to walk this park for exercise and could also make for a great Girl or Boy Scout project.
- A natural playscape would be a complementary addition to this park.
- Tree swings would be a good addition for park users of all ages.









Vestavia Ridge Pond

Vestavia Ridge Pond is a smaller stormwater detention basin located in the back corner of the Volente Hills neighborhood. The upland portion of the pond, along the street has a small, fenced dog run with dog waste station.

- Neighborhood children like to play in the basin portion of the pond and build forts near
 the trees and amidst the stormwater infrastructure. Look for opportunities to improve
 the functionality of the space for kids, as there are no other park spaces in this area of
 the neighborhood.
- The linear stormwater conveyance area along RM 2769 is accessible by walking along narrow grass walkways on either side of the Pond property.
- Need to improve maintenance of the vegetation in the basin.







Volente Hills Park

Volente Hills Park is a narrow park space tucked behind homes in the Volente Hills neighborhood, accessible via a rear alleyway. The park backs up to a new commercial area being constructed along Anderson Mill Road and is separated from this development by an 8-foot masonry wall. The park features playground equipment and some picnic areas.

- The park provides an enclosed and sheltered place for neighborhood children to play, particularly those who live in the homes that back up to the park. For those residents, the park functions almost like an extended backyard and common area for the immediate neighbors. However, the park's location also means it does not feel open and accessible to the public and may feel less safe for parents of children who don't live adjacent to the park.
- Although the play equipment in this park is dated, it is in good repair, safe, and usable.
- The entryway to the park is not well marked, which adds to the private feel of this park space.
- There are opportunities to make better use of the grassy areas of this park space.









Results: Focus Groups

On the day of Verdunity's site visit in May of 2021, the consultant also hosted several focus group discussion sessions to gather input from different park user groups. Focus group attendees were identified and invited to participate in the group discussions by Advisory Committee members. However, all members of the public were welcome to attend the sessions, and in some cases residents who were at the park at the time of the sessions were invited into the group discussions on the spot. Focus Group discussions lasted around 30 minutes. Below are the key take-aways from each of the focus areas.

Older Adults and Seniors Focus Group--Key Take-Aways:

- Older adults appreciate the gravel trails because they are gentler on the joints than paved sidewalks and trails.
- A collaboration with the Lady Bird Johnson Wildflower Center could help bring more wildflowers to the District.
- Washer courts or Bocce Ball courts would be a great low-cost addition to the District and could be used by all ages.
- Park maintenance is very important so that parks hold their value to residents.
- A swimming pool or water play area would be appreciated by people of all ages and would contribute to the value of the community.
- There needs to be better information available about our park systems, including maps that show where the parks are, what amenities are in each park, and how each park can be used.
- The fields in Hatch pond need stairs or a ramp for accessibility.
- The fields in Cashell Wood Pond also need accessibility features added.
- Old Mill Park is a blank slate. Simple improvements could enhance it.
- Most parks have some features for all users; however, none of the District parks prioritize seniors.

Children's Focus Group--Key Take-Aways:

- Smaller kids seem to have trouble with the large playground equipment.
- The updated playground equipment in the District is well-loved.
- The bathrooms need to be cleaner.
- The drinking water should be colder for the summer months and more fountains are needed.
- A bike or skate park area would be fun.
- A diversity of play areas helps bring a variety of kids to the parks
- Water play areas would be well-used by kids of all ages. A pool or even just a slip and slide would work!

- The volleyball court is mostly used as a sand pit for kids to dig in. It could be modified to reflect this use or the space could be reused for something else kids would enjoy.
- Signage for trails and parks could be used to navigate between parks.
- Parks get used differently as kids age.

Teenager's Focus Group--Key Take-Aways:

- Unique features that stimulate creativity help bring character to the parks.
- Open fields are used to play pick-up games like kickball.
- Several teens play disc golf with their friends or parents.
- Natural features kids can play on make great and inexpensive park amenities (e.g., hills/slopes, creeks, areas to build forts).
- A splash pad would make the parks much more enjoyable in the summer. It would not have to be elaborate; a simple water feature would do.
- A putt-putt golf course would be fun.
- A drone landing pad would be fun for teens who like to fly drones.

Runners and Bikers Focus Group—Key Take-Aways:

- Some residents prefer to run on the school tracks rather than the District trails.
- More sidewalk and trail infrastructure is desired in places that also provide safe places for play and exercise.
- The trails (and park system as a whole) needs better advertising and wayfinding features.
- Play for All Abilities Park in Round Rock is a great model for a kids' bike and scooter track.
- Trail running in the District parks is good but biking and skating is not as enjoyable.

Results: Survey #1

WTC MUD No. 1: 5-Year Park Plan

The first survey in the planning process (see Appendix A) was intended to provide the Advisory Committee and Verdunity with feedback regarding current park usage, opportunities and challenges associated with the current park system, and general preferences for the future.

Survey 1 was published on Monday, May 10, 2021 and remained open for public response for three weeks (through June 1st). Results were not reviewed until after the survey was closed. The survey was administered online through Survey Monkey, although a paper copy was also made available.¹

The survey was advertised to the community in the following ways:

- A link to the survey was posted on the front page of the District's website and also included on the District's Play in the MUD project page.
- Posts were made to multiple Facebook pages and community groups, and posts were also made to Nextdoor.
- Two large community signs (one marquee sign and one digital LED sign) were placed at Lakeline Oaks Park and Anderson Mill West Park, visible from Old Mill Road and El Salido Parkway (the District's two main collector roads).
- Small signs were placed in parks and on some dog waste collection stations. The signs included a QR code so people could link directly to the survey from their phones. The website address was also included on the sign.
- Advisory Committee members were tasked with helping to spread the word and encouraging neighbors to take the survey, which they did in several ways (verbal, text, email, social media).
- Direct emails were sent by the Lakeline Oaks Homeowners Association to Lakeline Oaks residents through the organization's existing communication channel.

Survey Participants

In total, the survey received 337 responses, although not all respondents answered all of the questions, so the number of responses varied. Although demographic information is presented up front in this report, these questions were placed at the end of the survey because they were considered of secondary in importance to the more substantive questions about the park system. Due to their location at the end of the survey, and possibly also due to some people's reluctance to divulge personal information, the demographic questions received a lower number of responses than the questions posed earlier in the survey.




Figure 2: Age of Respondents

Figures 1 and 2 show the gender and age composition of respondents. These survey questions received 255 and 249 responses, respectively.

¹ Although some paper copies were distributed, no copies were handed in.

As can be seen in Figure 1, there were twice as many female respondents as male. Figure 2 shows that a broad range of adult ages were represented in the data, with an overall average age of 47 years old. None of the respondents who answered this question reported being between the ages of 18 and 25, so the opinions of young adults are missing from the data.

Figure 1: Gender Identity of Respondents

Average age = 47




Figure 3 shows the household composition of respondents. This survey question received 252 responses. Overall, there was a good mix of adult respondents who have young children in the home, those with older children in the home (middle school and older), and those without children in the home.






Figure 4 shows how respondents were distributed throughout the District's four neighborhoods and also those who don't live in the District. Due to its size, the Anderson Mill West neighborhood was further broken into three areas, shown on the map to the right.

Based on the number of respondents who answered this question (255), there was representation from each of the District's four neighborhoods, and only 11 of those respondents reported not living in the District.

Figure 5 shows how many years respondents have lived in the District (this question was not asked of those who reported living outside the District). Based on the 244 responses to this question), the survey received responses from a variety of both longer-term residents as well as those who are newer to the District. The average across all responses was 11 years in the District.




Figure 6: Respondents' Homeownership Status

Further, 97% of those same respondents reported owning their home, versus renting or other form of living arrangement (see Figure 6).

Park Usage

The first set of questions in the survey were intended to help the planning team understand current park usage.

Closed-Response Question 1: Which of the following parks and ponds do you visit at least once a month? (check all that apply)

Anderson Mill West is the park reportedly used most by respondents, followed by Lakeline Oaks Park and Sun Chase Park effectively tied for second place. The ponds are reported to be used more frequently than the two very small pocket parks, Aster Pass Park and Volente Hills Park. Interestingly, 20% of respondents indicate using Old Mill Pocket Park at least once a month, despite its very limited selection of amenities, which may point toward its significance as a communal resource for this area of the District.

49 respondents (15%) indicated they do not use any District parks at least once a month.




Figure 7: District Park Usage

Those respondents who reported using any of the parks or ponds at least once a month were then asked two open-ended follow-up questions:

Open-Ended Response Question 1a: Please briefly tell us what you do when you visit these parks or ponds.

All responses to this question are available in Appendix B.

Based on a review of all responses received for this question (264), the most commonly repeated themes are summarized below:

- Walking/hiking/jogging/trail use: mentioned by 182 respondents (69% of 264)
- Playing with kids/playing on playgrounds: mentioned by 137 respondents (52% of 264)

Other repeated themes:

- Socializing/attending events, gatherings, parties: mentioned by 26 respondents (10% of 264)
- Passive activities like sitting, relaxing, meditating: mentioned by 21 respondents (8% of 264)
- Picnics: mentioned by 19 respondents (7% of 264)
- Biking: mentioned by 17 respondents (6% of 264)
- Tennis: mentioned by 15 respondents (6% of 264)
- Basketball: mentioned by 15 respondents (6% of 264)

Open-Ended Response Question 1b: *If there are any parks or ponds you do not visit, please briefly tell us why.*

All responses to this question are available in Appendix B.

Based on a review of all responses received for this question (211), the most commonly repeated themes are summarized below:

- Other parks aren't close enough/inconvenient location: mentioned by 126 respondents (60% of 211)
- Respondent didn't know about the other parks: mentioned by 52 respondents (25% of 211)
- Other parks don't have the right types of amenities: mentioned by 41 respondents (19% of 211)

For respondents who indicated they don't use any of the parks or ponds at least once a month, it was important for the planning team to understand why so that we can look for opportunities to better serve residents.

Open-Ended Response Question 1c: Please briefly tell us why you don't visit any of the District's parks or ponds.

All responses to this question are available in Appendix B.

Based on a review of all responses received for this question (37), the most commonly repeated themes are summarized below:

- The parks don't offer amenities of use or interest to the respondent²: mentioned by 12 respondents (32% of 37)
- No interest or time: mentioned by 10 respondents (27% of 37)
- Respondent didn't know about the District's parks: mentioned by 3 respondents (8% of 37)

Attitudes About the Current Park System

To gauge attitudes and opinions about our current park system, respondents were asked to indicate how much they agreed or disagreed with a series of eight statements using a five-point scale (Strongly Disagree, Disagree, Neutral, Agree, Strongly Agree).

Closed-Response Question 2: *Please indicate how much you agree or disagree with the following statements:*




Figure 8: Respondent Attitudes About the Current Park System

Figure 8 shows the distribution of responses for each statement. The vast majority of respondents (82%) indicated they consider our park system a valuable part of our community, and of the eight statements presented in this section of the survey, this statement received the most uniform, positive response.

The vast majority (76%) of respondents reported that they believe our parks are good places to socialize, and 55% of respondents indicated they would like to see more planned activities at the parks.

While nearly two-thirds of respondents (63%) felt our parks are well maintained, over one-third were either neutral on this subject (22%) or felt that they are not well maintained (15%).

Nearly two-thirds (61%) of respondents reported they do not know who to contact if they spot a problem at a park or pond. Similarly, only 38% know where to find information about the District's park system.

² Includes those who indicated they don't use the parks because they don't have children, which suggests the opinion that park amenities are oriented toward kids and not adults.

In terms of park amenities, half of the respondents (51%) agreed that the parks have a good variety of amenities for all users.

Out of the eight statements, "The District parks and ponds are accessible for persons with disabilities" resulted in the most uncertainty from respondents, with 59% indicating they are "neutral" on the subject.

Open-Ended Response Question 2: *Is there anything else you would like to share about the current state of our parks and ponds?*

All responses to this question are available in Appendix B.

Based on a review of all responses received for this question (160), the most commonly repeated themes are summarized below:

- Need to improve park maintenance: mentioned by 29 respondents (18% of 160)
- Would like to have a water amenity (e.g., pool, splash pad) in the District: mentioned by 23 respondents (14% of 160)
- Would like to have more amenities for dog owners (e.g., off-leash area, dog water fountains): mentioned by 11 respondents (7% of 160)

• Need to have better communication about our park system: mentioned by 11 respondents (7% of 160)

Respondents also used this open-ended question to make suggestions about specific parks. These are summarized below:

Anderson Mill West Park:

- Add more sand to volleyball court
- Install a barrier to keep balls from going into the street
- Take better care of the trees (mentioned in 2 responses)
- Build a pool or splash pad
- Refresh the trails
- Fix power outlets and bathroom locks

- Make sure programmed events and classes don't make it hard for residents to enjoy this park (mentioned in 2 responses)
- Empty the trash more frequently
- Install outdoor ping pong tables
- Install a skateboarding area
- Add better lighting

Aster Pass Park:

- Need more amenities for kids (mentioned in 2 responses)
- Trash cans should be checked regularly
- Convert this park to an off-leash dog park
- Remove the spiky cactus due to safety concerns

Little Elm Pond:

- The walking path needs to connect to something (mentioned in 2 responses)
- Need more amenities or something to do

London Lane Pond:

• Make water available to dogs at all times (mentioned in 2 responses)

Madeline Loop Pond:

- Complete the trail so it connects to something (mentioned in 2 responses)
- Repair wobbly handrails on bridge

Old Mill Pocket Park:

- Complete stone wall around the park to screen the wood fences
- Gazebo needs to be maintained (mentioned in 2 responses)

Sun Chase Park:

- Replace the playscape that was removed (mentioned in 8 responses)
- Improve maintenance (trash and mowing) (mentioned in 2 responses)

Volente Hills Park

- Plant nicer grass
- Improve the landscaping
- Refresh the mulch

Preferences for the Future of the Park System

The next series of questions was intended to give the planning team some direction in thinking about the future of the park system. Respondents were presented with 23 potential types of improvements, ranging from items as low-cost and simple as additional volunteer opportunities,

to more expensive investments like an aquatic amenity (e.g., splash pad).

For each potential improvement, a photo example was provided, along with a short title/description (e.g., water play areas). Respondents were asked to rank how much they wanted the item on a five-point scale (I really don't want this, I don't want this, I don't care either way, I want this, I really want this). There was also an open-ended comment box available for each potential improvement so respondents could elaborate on or qualify their rating of the item.

Closed-Response Question 3: There are many different ways we can make our park system better for everyone. Which of the following changes would you like to see? (photos are examples only)

Figure 9 shows the distribution of responses for each of the 23 potential improvements (total respondents ranged from 273 -277 across the 23 options). Of these, *Enhanced Trails and Paths* and *Water Play Areas* received the highest number of strongly positive reactions, with 40% and 38% of respondents, respectively, indicating "I really want this."


On the opposite end of the spectrum, *Unique Features and Photo Opportunities* and *Public WiFi* received the highest number of strongly negative reactions, with 25% and 24%, respectively, indicating "I really don't want this."




Figure 10: Preferences for Future Park Improvements, Average Ratings

Looked at another way, Figure 10 shows the overall average rating for each of the 23 potential improvements, from highest rating to lowest. Overall, *Enhanced Trails and Paths* was the type of improvement that received the most positive average response, followed by *Improved Lighting*,

Landscaping and Beautification, Quiet Areas, and Community Areas, with Water Play Areas and Volunteer Opportunities tied for sixth place.

Open-ended responses for each type of improvement can be found in Appendix B.

Figure 9: Preferences for Future Park Improvements Total # of responses: 273-277

Open-Ended Response Question 3: What other ideas do you have for improving the District's parks and ponds?

All responses to this question are available in Appendix B.

Based on a review of all responses received for this question (103), the most commonly repeated themes are summarized below:

- The community needs a water amenity (pool/splash pad): mentioned by 22 respondents (21% of 103)
- Need for more natural areas: mentioned by 11 respondents (11% of 103)
- Need for more dog parks/dog amenities: mentioned by 9 respondents (9% of 103)
- Need more events and community gatherings: mentioned by 8 respondents (8% of 103)
- Don't add anything/don't spend more money: mentioned by 8 respondents (8% of 103)

Respondents also used this open-ended question to make suggestions about specific parks. These are summarized below:

Anderson Mill Pond:

Add more amenities

Anderson Mill West Park:

- Improve the basketball court
- Add a training tennis wall (and/or at the Lakeline Oaks courts)
- Install a fence to keep kids from running into the street

Aster Pass Park:

• Add more play equipment

Hatch Pond:

• Improve access

London Lane Pond:

Install a water source for dogs

Old Mill Pocket Park:

• Install stretching equipment

Sun Chase Park:

- Install a new playscape
- Add swings
- Install grilling areas

- Add better shade over the little kids play area
- Install a splash pad

Open-Ended Response Question 4: What are the best parks you have ever visited and what made them so great?

All responses to this question are available in Appendix B.

Based on a review of all responses received for this question (121), the most commonly repeated themes are summarized below:

Best parks:

- Play for All Abilities Park, Round Rock: mentioned by 17 respondents (14% of 121)
- Brushy Creek Park, Cedar Park: mentioned by 10 respondents (8% of 121)
- Elizabeth Milburn Park, Cedar Park: mentioned by 6 respondents (5% of 121)
- Zilker Park/Botanical Garden, Austin: mentioned by 6 respondents (5% of 121)

What makes a great park:

- Natural beauty/access to nature: mentioned by 38 respondents (31% of 121)
- Wide variety of amenities/inclusivity: mentioned by 34 respondents (28% of 121)
- Has a water amenity (e.g., splash pad): mentioned by 13 respondents (11% of 121)

Open-Ended Response Question 5: Is there

anything else you would like to tell us about the District parks or ponds?

All responses to this question are available in Appendix B.

Based on a review of all responses received for this question (48), the most commonly repeated themes are summarized below:

- General appreciation and support for the park system: mentioned by 16 respondents (34% of 48)
- Request not to spend additional money on parks: mentioned by 6 respondents (13% of 48)
- Appreciation for the survey/opportunity to provide input: mentioned by 5 respondents (11% of 48)
- Make sure people who don't live in the District don't get to have a say in the future of our parks: mentioned by 4 respondents (9% of 48)
- Keep up with maintenance: mentioned by 3 respondents (6% of 48)

Survey Limitations

As with any survey, there are limitations in the data and methodology that must be acknowledged and considered. Below is a summary of observed limitations, followed by a brief discussion of how these limitations were considered during analysis.

• Survey respondents were self-selected, meaning that individuals who knew about the survey decided whether or not to take part in it, and that decision alone could represent something about those people that influences the data collected. For example, the people who choose to take a park survey may, on average, feel more strongly about parks, one way or another, than the average District citizen, so their responses to the

questions may be inherently differently than those of someone who didn't choose to take the survey.

- Based on the available data, the opinions of young adults (18-25) were absent entirely from the dataset, and women outnumbered men two to one.
- The survey was online, and even though paper copies were made available, they were not as widely accessible as the online version of the survey, and not nearly as convenient to turn in, which means that people who are not comfortable using the internet or don't have easy access to the internet were much less likely to take the survey.
- Although considerable effort was made to ask questions that were clear and unambiguous, no survey is perfect, and after looking at the data, there were a few instances in which respondents indicated they didn't understand the question. It is also possible and even likely that some respondents answered a question based on their own interpretation of the wording.
- Most of the questions asked about the park system in general, rather than about specific parks. But as the results show, park users often use only a few of the District's parks and ponds, and some report not using them at all. So, for some of the questions, respondents may have felt less inclined to express a strong opinion either way if they felt they didn't know enough about the park system. In other words, some of the "neutral" or "I don't care either way" responses could have been a function of respondents not knowing enough about the park system to warrant an opinion, even if they use one or two parks regularly.

Acknowledging these limitations, the planning team's objective in analyzing the survey results was to look for the key *stories* or clear *patterns* in the results that could allow more in-depth idea exploration. To identify these patterns, the planning team looked not only at the results of the closed-response questions and the descriptive statistics associated with those questions (e.g., percentages, averages), but also looked closely at how responses interrelated with the responses to other questions and also took great care to read and analyze the abundant number of openended responses.

In doing so, we have made the observations described in the Key Directions section at the beginning of this report, which are serving as the foundation for the next steps in the planning process.

Methodology Questions Raised by Residents

During the survey response period, District residents raised a couple of concerns regarding survey methodology, which we have identified and addressed below:

Question 1: Since the survey was open to anyone who uses the District's parks, including people who do not live in the District, some residents were concerned over non-residents having a say in the future of the District's park system, since they aren't the ones paying for it.

The decision to open the survey to anyone who uses the District's parks was an intentional one. The purpose of the first survey was to get a sense for people's experiences with the parks, who uses them, what works, where problems and conflicts exist, what observations people have, and what, generally speaking, would make people more excited about visiting the parks. Several of the District's parks are used frequently by people who live around but not in the District--just as our District residents use nearby City of Cedar Park and City of Austin parks--and those people might have valuable, interesting things to share about the way our parks operate that the planning team wanted to capture.

That said, the concern over non-taxpayers having a say in future District investments is a fair one, and because of this, the survey did ask respondents where they live so we could evaluate the responses of District residents apart from non-residents. A review of the results reveals that only 11 respondents reported not living in the District.

Since the primary concern about non-residents taking the survey relates to how we plan for *future* improvements, and not necessarily non-residents' opinions about the current state of our parks, the planning team looked closely at the question that asked respondents to rate potential future improvements, and for each one compared the average of all the responses with the average without the 11 non-resident responses.

In addition, there were 82 respondents who did not answer the question about where they live, and it is of course possible that some of those were non-residents. So, to be extra thorough, the planning team also pulled out the responses of any respondent who didn't answer the question about where they live and added that to the 11 self-reported non-residents and, again, compared those averages with the averages of all respondents.

The results of these comparisons can be seen in Figures 11 and 12. As this analysis shows, no meaningful differences were found. In other words, the responses of non-residents were not meaningfully different than those of residents.

Question 2: A few residents expressed concern that individual respondents could take the survey multiple times, thereby skewing the data.

Respondents could only take the survey once from the same device, and to account for the fact that most people these days have access to more than one device (phone, laptop, tablet), Survey Monkey does collect the IP addresses of all respondents as well, so surveys submitted from the same network can be identified as such.

In all, there were 32 instances of duplicate IP addresses in the responses, and the planning team ran a check on each one to make sure they were unique responses. There was no obvious indication that anyone was taking the survey multiple times, but rather the duplicates were the result of there being more than one respondent from the same household (e.g., spouses).

This check is, of course, not perfect. If someone wanted to go out of their way to manipulate the data there are ways around this. But after a very thorough review of *all* the data and the written responses, there is no evidence that people were trying to bias the data by taking the survey repeatedly.

One respondent openly reported having taken the survey five times. However, there were no instances of an IP address being repeated that many times, nor do there appear to be instances of the exact same responses being duplicated. So, although it's possible, the planning team feels confident that of the various limitations to this data set, this particular issue is not of significant concern.





Too much trash, bottles and plastics littering the parks and ponds.

I'd love for signs that educate everyone about this area being the traditional and ancestral homeland of the Tonkawa people (and several other tribes have been a part of this area in more recent history, too), shares about some of the native plants in the area and the significance they hold, and potentially ways to learn more and support the displaced tribe today.
